The Indigenous Education update highlighted progress in student achievement, recent legislative changes under Bill 40, and the continued partnership with the WV Indigenous Education Council.

West Vancouver Schools has strong three-year trends; Indigenous students consistently outperform provincial averages in literacy and numeracy and are on track for 100% on-time graduation this year. Superintendent Kennedy emphasized the district's commitment to inclusive education and acknowledged the importance of Indigenous voices, worldviews, and cultural perspectives in shaping student success.

The 2025–2026 school fee structure was presented, with most fees remaining steady. Increases were noted in both academy and transportation-related fees due to rising bus and staffing costs.

Annual Budget Bylaw

1784 MOTION THAT a Bylaw of THE BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 45 (WEST VANCOUVER) (called the "Board") to adopt the Annual Budget of the Board for the fiscal year 2025/2026 pursuant to section 113 of the School Act , R.S.B.C., 1996, c. 412 as amended from time to time (called the "Act".)

- 1. The Board has complied with the provisions of the *Act*, Ministerial Orders, and Ministry of Education and Child Care Policies respecting the Annual Budget adopted by this bylaw.
- 2. This bylaw may be cited as School District No. 45 (West Vancouver) Annual Budget Bylaw for fiscal year 2025/2026.
- 3. The attached Statement 2 showing the estimated revenue and expense for the 2025/2026 fiscal year and the total budget bylaw amount of \$108,009,392 for the 2025/2026 fiscal year was prepared in accordance with the *Act*.
