## Chair Report - Nessa Van Bergen

## Guest Speaker - Mike Finch (Principal, Sentinel Secondary School)

- Spoke about Sentinel \& Chartwell relationship, great opportunities for students in both schools
- Kids interested in Chartwhale (or have worked on it) would like to attend Library Commons event on March 6th
- If kids attend Chartwell the assumption is that they will attend Sentinel
- Idea is to build energy around making the new Grade 8 students feel welcome as they are making connections and becoming more familiar with their new school in Grade 7
- Hosting volleyball jamboree
- Leading up to orientation later in the Spring for all new students who spend half of a day in Sentinel
- Capstone Program - Sentinel is a strong academic school with focus on AP courses. Kids who take these courses get dual credit - Grade $12+1$ st year university
- Great relationships have been fostered between kids and staff
- Spartans camp is hopefully going ahead despite staffing changes
- Program called Connect, for kids that aren't designated but who need additional support \& structure with organisation skills and any concerns they have
- Focused on learning
