Chair's Report

She has settled into the school with grace, bringing with her kindness and efficiency which has made the transition seamless for all interactions.

At the start of the New Year we introduced a fourth day to our hot lunch program. Despite continuing issues with enough volunteers to support this, a core team including Brenda, Grace, Lisa and a handful of others have taken on the management of this every week without fail to make it a huge success. Thank you to all the volunteers who make this possible - we really do appreciate your commitment this year.

Throughout the Spring the PAC have sponsored innovative maker tech programs and the purchase of new equipment to further support design, coding and electronics in all divisions in the school - activities hugely enjoyed by the students.

And so that brings me up to date with the very recent production of the Sound of Music. Words do not do justice to the sheer amount of hard work and determination that went into the incredible performances at the Kay Meek theatre - from staff and students alike. What an achievement.

I'm sure we are all very much looking forward to another successful Multicultural Night tomorrow evening and then we still have a few more events to come in June. Big projects for next year are currently not confirmed as we really need to engage more parents to support our fundraising initiatives but we have lots of ideas to consider - a new playground in the lower field and upgraded grounds surrounding it are still a possibility as well as a school garden and possibly even a kitchen renovation.
