4.1 The Treasurer, Christy Stasheck

Nothing really to report so early in the school year. Hot Lunch is open, \$5,000 has come in. Financials attached to minutes.

The gaming grant has come in yet, usually around mid-October.

5. Principal's Report - Warren Zerbe

Taking Grade 6 to overnight camp next week. The \$5000 funds from RPAC reduced the cost for each student to \$210 (covers transportation, food, activities). Great way for kids to connect. Mr. Zerbe thanked the RPAC for its assistance in reducing the costs for students to attend.

Cheque Writing Campaign funds from last year are mainly spent. Upgrade of kindergarten classes and Grade 1 classrooms, new jerseys all purchased.

Teachers receive \$400 per division for extras for the RPAC and the funds are greatly appreciated.

Terry Fox run is Thursday September 22, 2022.

Grade 4/5 split classes this year, only way to not turn students away from the district. Mr. Zerbe recognized it was a bit of a shock for parents. School administration was told by the district a week before school started.

Enrolment is 397 (max 407). 275 families live nearby, others are from outside the district.

This term, working on sense of belonging as a school goal.

October 7, 2022 – will be sharing about themselves.

FSA exams -coming for Grade 4 and Grade 7.

There are awards for Grade 7s at the end of year for academics, physical education, community service etc.

September 29th is photo day and also orange shirt date. Children are allowed to bring a change of clothes for pictures, they do not have to wear orange for their pictures.

There was a question about whether the Grade 7s could assist with traffic at pick up and drop off. Mr. Zerbe commented that it is too risky to put students in that position given previous experiences in prior years. The options are for WVPD and Bylaw to have more of a presence or parent volunteers. Mr. Zerbe will ask about crossing guards and bring to Chris Kennedy's attention. Ling He added that there is resource shortage. Ling also recommended that every incident parents (near

accidents) see should be reporting it to the non-emergency policy line. We will circle back on this topic at our next meeting.
