Hot Lunch

Ordering closed ,173 orders about \$32000

Added new item on pizza day as a snack. It's a new vendor - rice triangles in 3 different types.

Maybe try to do a special lunch day similar to a hot dog day to test it with the kids

This is Brenda's last term coordinating hot lunch.

2 vendors are charging GST and we need to discuss this with them. Nessa following up on this. We won't use them next year if they continue to charge GST. All of the other vendors do not and it works out to about \$100 per week.

Ask Saputo if we can order drinks per term, instead of weekly. Brenda will follow up.

Grade 7 Farewell

Valentino grams profit of \$465 towards grade 7 graduation. 7th graders helped sell them.

March 9 and April 7 Hot dog days

They need volunteers to help. They would like to involve 7th and 6th grade parents, and they are adding a vegetable hotdog to options. They will also put both dates form the same order form so parents only have to fill it out and send in money one time.

Playground Enhancement

Committee has been formed

Possible MOR grant hopefully awarded in the next month.

Need to move forward with having a grant in place

Habitat playground system – we are required to work with them.

Site for exploration with Habitat employee recommended getting rid of what we have. Part could be saved, but would it be right thing to do. It will have to be removed in next 5 years.

Swings are good for now and do not need to be replaced.

Surfaces- grass like surface around \$20 per sq/ft might be good in a specific area or wood chips, rubber \$25 per sq/ft.

Wood chips are considered accessible.

Where the wheelchair ramp ends, possibly put grass like area with a mural on the wall on the side of the ramp.

Natural objects could be a possibility as a climbing section.

Fundraising services/opportunities - Habitat can help with that if we want their assistance.

We can do any color combo that we want.

A lot of work has to be done at the site before installing new equipment.

We will need to dig down 15 inches for wood chips in order for it to be accessible and at a flat plane with the rest of the land around it.

Drainage could potentially cost approximately \$25000 based on other projects they have done.

Habitat does the drainage, so it is under warranty.

5. Physical Literacy

Potentially have physical literacy group to attend pancake breakfast to give parents more info about physical literacy. What is it? The motivation to move, confidence to move, competence to move, mental wellness or mental wellbeing, social involvement, physical literacy at home.
