## Technology User Agreement Grade 3 & 4

Dear Students,

You will have the privilege of using Laptop Computers and iPads this year at Pauline Johnson. These technologies will be used as a tool to enhance your learning and engage you in unique and dynamic ways. Laptops and iPads are not toys; they are tools to help you learn. In order for you to be successful in your learning with these devices, please read the following student expectations carefully:

### **You are responsible for reading, understanding and following the expectations below:**

I will use PJ Laptops and iPads in a safe and respectful manner. This means:

- I will have clean hands and a clean workspace when using Laptops & iPads.
- I will have no food or drink near the Laptops and iPads.
- I will use both hands and never run when I carry the Laptops & iPads.
- I will only use a device when supervised by an adult.
- I will not leave a device on the floor.

I will follow SD 45 guidelines and teacher instruction while using either the school's Laptops & iPads, or my own device. This means:

- I will only use Apps and educational websites I am asked to visit and I will immediately tell a teacher if I accidentally find an inappropriate site or image.
- I will not add, move, delete or alter anything on the school's iPad or Laptop desktop and hard drive.
- I will not alter or modify anyone's work except my own.
- I will not download images or text without citing where it originates. I will cite all sources I use in my research to respect copyright laws.
- I will not take photos or video without permission.
- I will not publish a person's photo without their permission.
- I will ask for permission prior to printing anything.
- I will not visit or participate in email, online gaming, social networking sites, etc.
- I understand that school and/or network administrators have the right to inspect and monitor my activities and files stored on the school server for security purposes or if misuse is suspected.

I will follow PJ guidelines for cellular device use. This means:

- From 8:45-3:01, my cell phone will remain in my backpack.
- I will not use my cell phone during recess, big recess or lunch.
- I will not take my cell phone to the washrooms.
- I will only use my cell phone for learning purposes with permission and the supervision of the teacher I am working with.

Use of all/any technology at PJ is a privilege, not a right. I will follow the expectations listed above or will not be able to use these devices. If I do not follow the expectations, I will have a meeting with my parents, my classroom teacher, and Mme Trudeau/M Parslow to review this agreement and decide when I am able to use technology at school again.
